Participant Disclaimer General

- 1) I understand that my participation involves a degree of risk. However, I confirm that neither the organiser of the event nor Red Bull GmbH ("Red Bull") nor any of its related companies are to blame in any way if I get injured. I am in possession of a valid personal liability insurance and personal accident insurance that cover my participation. If I cause damage to anyone else or their property, I will take the blame and I will make sure that the organiser, Red Bull GmbH or any of its related companies will not incur any damage in this regard.
- 2) I agree to comply with the organiser's rules of competition and safety for my own good and everybody else's. I have checked my equipment which is in good working order, properly maintained and suitable for the event and I'm aware that I'll only be allowed to take part after a positive on-site inspection and/or safety check.
